C. Small Business Membership: \$225 - \$600

For companies that wish to provide up to 3 of their owners, management, staff, and employees access to education, networking, and professional development, and who wish to promote their company, products, and/or services. Small Business members are eligible to enter the annual Judging & Competition or exhibit at Meet the Cheesemaker. Small Business members receive 1 vote per company, allocated to the Primary Member on file.

D. Corporate Membership: \$800 - \$3,000
